### **BOOST SCHOLARSHIP INFORMATION**

Students on free and/or reduced lunches are eligible for the Boost. Students will be held responsible for charges above six credit hours. Boost does not apply to program fees associated with Senate Bill 155. (Hybrid course fees are not covered.)
