Holopirek Named ECF Volunteer of the Year

The Ellsworth Correctional Facility held its annual employee and volunteer recognition activities May 23. The ECF Volunteer of the Year is Darnell Holopirek.

Darnell has represented BCC as a volunteer at ECF since 2005. She has helped a team from BCC develop and grow the education program at ECF, and more recently, at Larned Correctional Facility. Since 2005, Darnell has raised funds to pay for 163 scholarships for inmates to take BCC classes while incarcerated. Her goal is to have enough scholarships so

that any inmate who wants to pursue their education can take classes. She instituted the textbook loan program, which allowed many other inmates to afford BCC classes.

Darnell and her team have also brought Work Force Training to ECF and designated ECF as a Partner in Education in 2013. She was given the Distinguished Service Award by the ECF Post Rock Jaycees in 2009. Since 2012, she has served on the ECF Spiritual Life Center (SLC) Board of Directors. In that capacity, she has set up SLC speaking engagements in community churches, which have raised funds for BCC scholarships and the SLC. Darnell also serves on the expansion committee for the SLC Board of Directors.

She and the BCC team also pro-

vide items for SLC Christmas packages which are given to all ECF inmates, so they, too, can enjoy the holiday season. Darnell commented, "I was very pleased, and humbled to receive this award."
