Barton Community College hosted a "Meet and Greet" for Nancy Wiebe, the new Executive Director of the foundation, on July 30 at Great Bend Coffee Company. She spent her first month in July meeting community leaders and supporters with the help of retired Executive Director Darnell Holopirek.

A native of Caldwell, Kan., Nancy comes to the Barton Community College Foundation with a strong background in nonprofit administration, foundations and fundraising. She is a graduate of the University of Kansas with a Bachelor of Science in Journalism and a Master of Business Administration. She has spent the majority of

Paul Maneth, was part of the earliest contingent of Barton hires in 1970. He became director of Admissions and Financial Aid for the college and eventually became Dean of Instruction. He, along with other college leaders spearheaded military, on-line and high school class course venues. After his retirement, Paul served six years as a college trustee. He chaired the foundation's academic enrichment fund campaign in 2014. Paul established a fund to help with faculty development, an often overlooked area of need that helps the college remain progressive. Paul and his new bride, Mary Kummer, are both long-time residents of Great Bend and supporters of the foundation.



Nancy Sundahl and her husband Kevin were in the first class of students at Barton Community College. 


Letter from the Past Chair and Interim Executive Director, Rob Dove



Medical Society Donation supports Education of Health Professionals



This summer Barton County Medical Society donated more than \$7,000 to the Sister Mary Ann Klein, OP Nursing Endowment at the Golden Belt Community Foundation. In the past this endowment supported the purchase of an additional SimPad controller at Barton Community College to help train new nurses. The endowment was started by Barton Community College Foundation, Clara Barton Hospital and the former St. Rose Foundation to provide funding and support for the recruitment, retention, and training of health professionals and health educators, including opportunities for scholarships, equipment for training and continuing education.

Winged Aspiration rises

A striking new bronze sculpture is being completed and placed in the circle drive fronting the Fine Arts Building at Barton Community College. "Winged Aspiration" is based upon a smaller wax model sculpted by L.E. "Gus" Shafer. 








37th Ghostly Gala Auction

Watch for student drivers in the new Barton Commercial Driver's License (CDL) training program. The first class completed June 26, and the program has a waiting list approaching 40. Purchase of the truck was made possible by a gift from the William C. Wells Trust via the Barton Community College Foundation. The college is researching acquisition of a simulator to "keep the wheels" rolling on this muchneeded program.





The Camp Aldrich Conference Center is scheduled for completion by December 2015, well ahead of the foundation's 7th Clay Shoot Competition scheduled April 17, 2016. Fire destroyed the former conference center weeks before the 2013 Clay Shoot, causing a two-year delay in this popular event.
