## **OSHA 2255 – Principles of Ergonomics (\$649)**

Course topics include work physiology, anthropometry, musculoskeletal disorders, use of video display terminals, and risk factors such as vibration, temperature, material handling, repetition, and lifting and patient transfers in health care.
