a. The TCOs will sign out only the number of test booklets required to administer the exam and plus one for the test administrator; at no time will the answer key be present during the administration of the test.

b. Test administration will be conducted with at least two versions of the exam.

c. The Test administrator (TA) will perform the following steps:

1) Positively verify every student's identity before administering the test. Have students place their identification card on their desk. Utilizing the class roster, go to each student and verify name and SSN with ID card. If the TA is familiar with the students, checking the ID card is not necessary.

2) Issue the AIMS Answer Sheet and student workbook (if required for the exam) to each student. Instruct students to fill out the following information on the form:

a) Name - Last, First, MI.

b) Rank.

c) Course. Enter 92Y10-AIT.

d) Class. Have student enter their class number.

e) Exam PFN. Enter 92Y10D03.

f) Date. Have student enter date the exam is taken (current date) (DD MMM YYYY format).

g) Social Security Number. Have student enter the last 4 of their SSN. There is no need to fill in the corresponding bubbles.

h) Test Number. Have students enter the Version (A, B, or C) and test booklet number.

3) Advise students of the following:

a) They will not acquire or provide inappropriate assistance either before, during or after the test, except as instructed.

b) They will report any unauthorized assistance of which they have knowledge.

c) They will not divulge any information contained within the test.

4) The student will acknowledge this advise by writing the statement "**I certify that I have not received any unauthorized assistance and will not divulge the contents of this test to others.**" on the back of the AIMS Answer Sheet. The student will sign and date the statement.

5) Issue the following instructions to the students:

a) If a student has a question, the student will move to the location of the TA bringing the test and answer sheet. **NOTE: The TA will only clarify the question; do not provide guidance for a test question nor prompt a correct answer.**

b) If a student has to use the restroom they will turn in their test, answer sheet and scratch paper to the TA. Only one student may use the latrine at a given time.

c) Students may **NOT** have personal electronic devices (cell phone, Blackberry or laptop computer) in their possession or in operation while testing. Soldiers authorized to possess electronic devices will turn them into the instructor before testing begins and receive them after completing the test.

d) If a student becomes ill, they will be excused from the exam and not permitted reentry during this testing session.

e) Students will not mark on the exam.

f) Students will completely fill in only one bubble per question. If a student wishes to change their answer they must completely erase the original bubble and fill in the bubble of their choice.

g) Upon completion of the test the student will turn in the test, answer sheet and scratch paper to the TA and exit the room.

6) Issue a test to each student instructing them to annotate the Version and Test Number on the AIMS Answer Sheet. Instruct the student to ensure they have sequentially numbered questions appropriate for the test and close the test. Correct any discrepancies.

7) Strictly adhere to all allotted examination times. You must post the start and stop times on the board so that all students can read them. Periodically announce the time elapsed or the time remaining.

8) TA will circulate through the room ensuring all students are complying with the Test rules.

9) After the allotted time for the examination expires, instruct all students to stop. Collect all test materials as quickly as possible. strictly account for all test booklets, answer sheets, and scratch paper in roster number order. Before dismissing examinees check test booklets to ensure that no pages are missing or contain markings.

10) The TA will report any suspected test compromise, test loss or incidents of cheating to the TCO immediately upon discovery.

a. **Grading of Tests.** The TAs are the only personnel authorized to grade tests. The tests will be graded in a test control area. All answer sheets will be hand scored by the following method.

1) Ensure that all lines have only one bubble filled. If not, this question is counted as being incorrect.

2) Align the scoring key over the answer sheet. Visually go down each line to identify unmarked answer spaces. This identifies the number wrong. Convert that number wrong into a percentile score and record it on the students answer sheet.

3) All exam failures must be checked independently by a second person. The accuracy of the count can be checked by totaling the number of wrong answers and right answers. The total should equal the highest possible score for the test.

4) Once all tests are graded, the TCOs will provide the instructor with the test review sheets.

b. **Test Item Analysis.**

1) TAs will conduct a test item analysis after each exam.

2) At the beginning of the exam, the TA issues each student a sheet of paper numbered to correspond with the questions.

3) Have the students write their names and student numbers on the sheet of paper.

4) Tell the students that the sheet of paper is for a test review, that it is not an answer sheet.

5) Once the students complete the exam, the students will turn in the test booklet and the test answer sheet to the TA.

- 6) After the TA grades the examination, the TA may begin the Test Review. Conduct the test review by using one test booklet of each exam version issued.
- 7) After completing the test review, go over each missed question only and discuss the correct answers with the students.
- 8) At the conclusion of the test review, the TA will collect all test review sheets and turn them into the TCO for destruction.

c. Test Review.

- 1) After all students pass the exam, to include the retest, the TA will conduct a test review. A test review is a learning activity that occurs after the grading of the exams. A test review will be conducted on all tests.
- 2) No class will be allowed to advance to the next block of instruction before conducting a test review.
- 3) The TA will coordinate with the TCOs for the issue of the test review. The test review will not be out for more than one (1) hour of scheduled training time.
- 4) Before beginning the review, students will remove all note taking material and electronic media from their use.
- 5) Provide the student with the test review sheet for the exam. The TA will only review missed questions for each version of the exam.
