Kansas 4-H has been fortunate to receive a grant to help with summer programming. This grant will allow many counties to hire interns this summer to help with the impact of learning loss over the past couple of years. I am looking for two interns that would be willing to help with summer daycamps and the increased use of lessons that have been created and helping us to collect evaluations that show the impact of our Extension Programming. The interns can be college aged youth, teachers that are looking for a summer position or adults who want to work with youth in an educational setting.

The Intern Program Description:

The Kansas 4-H Summer Engagement: Helping Youth Discover their Spark to Increase Learning Program seeks to directly address the impact of learning loss as a result of loss of instructional time. The program will leverage the rich curriculum basis available through the Kansas 4-H and Cooperative Extension system. The evidence informed programmatic outreach is specifically designed to foster youth Spark through 4-H project based exploration. Working in partnership with Local Extension Agents, summer interns will deliver content through intensive SPIN (Special Interest Club), day camp, overnight camp, and workshop offerings.

What is Included in the Program:

- Paid Intern for a 12 week program (May 23rd – August 12th) at \$17/ hour
- Summer programming budget of \$5,000 per intern
- Each intern will be equipped with a laptop with an external speaker and backpack
- Access to teaching technology (projector, laptops, cameras) to be checked out for programming
- Curriculum for 2-3 4-H programs (Example Junk Drawer Robotics, Facilitators Guide, Food Science, STEAM Clothing, ETC.)
- Support from local site engagement leaders
- Professional development and 4-H content training

Possible Suggestion of Intern Positions for Walnut Creek District (Ness, Lane and Rush Counties) or NW 4-H Advisory

- Walnut Creek District position would be helping with Daycamps throughout the summer. Office location would be Ness or Rush County.
- NW 4-H Advisory position would include traveling around NW Kansas and helping to implement lessons that have been created through the Kansas Clover Classroom. As well as helping to gather the evaluation information on the lessons to help reach an impact for Kansas 4-H. Office location would most likely be Ellis County Extension in Hays.
