The application process will include:

1. Internship Application ([Download PDF](#))
2. Current Resume
3. Signed and Dated Rules Consent form
4. Two Letters of Recommendation (In sealed envelopes attached to application)
5. A Statement of Interest (Should highlight specific areas of interest for the internship and should not exceed 500 words)
6. (Optional to Candidate) Additional Writing Samples may be provided
7. (Optional to office/agency) Phone or In-Person Interview

Application review for the spring and summer term will begin on October 1. However, applications will be accepted on a rolling basis until January 1 for the spring term and April 30 for the summer term.

(Priority will be given to applications received or postmarked by the dates above - applications received after the deadline will be reviewed as long as internships remain available.)

The program will be co-coordinated by three person committee: a representative of the Governor's Office (Shawn Cowing), a representative of the cabinet level agencies (Jackie McClaskey), and a Cabinet Secretary (Col. Ernest Garcia, Superintendent - Kansas Highway Patrol). The Coordinators will work with intern supervisors and help develop program goals and expectations.

Applicants for each office will be forwarded to the Director/Secretary for the opportunity to list preferred candidates. The coordinators will work to match the most qualified candidates with the best opportunity for their skills and interests.

Interns will attend an orientation program prior to the beginning of their internship. All interns will attend regularly scheduled educational programs. For example, each Cabinet Secretaries would be asked to present to the whole group on the activities and responsibilities within their agencies. Other programs and activities for the group may be scheduled during their term. Cross-agency projects will also be explored.
