Detail:

The college currently is insured by Midwest Higher Education Compact (MHEC). A number of other Community Colleges have also joined this program which enables us all to share in the benefit of being in a large pool with the other colleges. Deductible remains at \$25,000 for property.

Conrade Insurance Group is our current broker, and coordinates all of the different insurance companies under the MHEC umbrella (Lexington, Wright, Cincinnati, Hartford, Travelers, etc.). The next page will show you the renewal numbers and how they compare to past years numbers.

The values provided for the renewal are not to exceed values. We anticipate that the Property number may change slightly (lower). MHEC does not finalize their rate until mid-June.

Recommendation:

The college administration is recommending that the Board approve the renewal as presented from Conrade Insurance Group. Our new insurance will take effect on July 1, 2017.
