- Certifies program meets acceptable state and accreditation requirements and specified debt-to-earnings measures

## Higher Education Act: State Authorization

- State Authorization Reciprocity Agreement (SARA) an agreement among member states, districts and U.S. territories that establishes comparable national standards for interstate offering of postsecondary distance-education courses and programs. (<u>http://www.nc-sara.org/content/sara-policies-and-standards</u>)
- Purpose ease the ability for students to take online courses offered by postsecondary institutions in a state other than the one where they reside.
- SARA is overseen by a national council and administered by four regional higher education compacts, MHEC, NEBHE, SREB and WICHE. The four SARA agreements of those compacts are collectively treated as a plural, the Agreements.
