## Kansas Systemwide General Education (GE) Program

- KBOR approved in June 2022
- Board of Regents goal to create a common general education package and facilitate student transfer.
- Impacts AA, AS, AFA and all baccalaureate degrees. Does NOT impact AGS and AAS
- For students starting in the Fall 2024 semester and thereafter, each state university and community college will adopt the <u>systemwide general education (GE)</u> as the single GE for all its native and transfer students.
- An institution can use its institutional GE for students who start as late as summer 2024.
- Credit hour difference: Statewide = 34-35 credits; Barton 36-42



#### **Next Steps**

- The Programs, Topics and Processes (PTP) Committee and Learning, Instruction and Curriculum Committee (LICC) are responsible for Barton's implementation plan.
- June & July reporting is complete; awaiting feedback from KBOR
- We are transitioning from our current curriculum guides to the required academic degree maps. - Adjust college transcripts to reflect "KS Systemwide General Education Completed"
- Complete annual reporting including degree maps
- Work in conjunction with the General Education Council



### AY 2024-AY 2026 Performance Agreement

- corequisite support developmental education
- math pathways
- systemwide course placement measures
- academic degree maps

These will trigger necessary actions that will help drive innovation, reduce achievement gaps, and enhance student success and completion for all students."

### Project-Based Performance Funding Structure

- Math Pathways (20%)
- Corequisite Math Support Developmental Education (20%)
- Corequisite English Support Developmental Education (20%)
- Systemwide Course Placement Measures (20%)
- Academic Degree Maps (20%)

"If new legislative dollars are allocated to higher education, an institution will receive a full performance funding allocation by simply participating and meeting basic conditions in the five aforementioned projects."



## Systemwide Elementary Education (PK-6) Transfer Associate Degree

- Creates a degree plan in which all courses completed transfer and apply toward the completion of a baccalaureate degree at all six state universities and Washburn.
- Career goal licensed as a PK-6 elementary teacher.
- AA or AS community colleges are strongly encouraged to only offer one version of the degree to avoid confusion. There will be no course difference between an AA or AS.
- Requires a decision to submit our written commitment to offer the degree, submit a degree check sheet for approval, develop new courses and add a new program in the KBOR inventory system.
- Launch fall 2024; however, advisement for fall begins in March 2024
